# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to https://www.artsandmindfulness.com, and Emily Olson | Arts + Mindfulness and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Emily Olson | Arts + Mindfulness include https://www.artsandmindfulness.com and Emily Olson. By using the Emily Olson website, you consent to the data practices described in this statement.

## **Collection of your Personal Information**

In order to better provide you with products and services offered, Emily Olson may collect personally identifiable information, such as your:
